#### SURFACE WATER

Mr. Samuelson stated that he has not received a good sense that there would be any additional water available this year for Out-of-District contract holders. Director Ben Crane requested that Mr. Samuelson investigate the possibility of purchasing an additional 100 af to add to his Water Supply Agreement for the remainder of the contract. Both Directors McNab and Couchman stated that they would check with Mark as to their need for additional water.

Mr. Samuelson reported to the Board that See's Consulting should have their Preliminary Soil Investigation Report completed within 2-3 weeks.

# GROUNDWATER SUSTAINABILITY AGENCY UPDATE

Mr. Samuelson explained to the Board that the Merced Subbasin Groundwater Sustainability Agency (MSGSA) should have their Draft Allocation Policy available for review in June. Director Bert Crane communicated to the Board that MSGSA was holding a Workshop on May 22, 2024, and encouraged all Directors to attend.
