SURFACE WATER

Mr. Samuelson shared with the Board that MID had approved in their budget the sale of 40,000-acre feet of 10-year transfer water for 2024.

GROUNDWATER ELEVATIONS AND APPLIED WATER

Ms. Lindeman presented to the Board the Fall 2023 and historical district wide groundwater levels and water applied, both ground and surface for years 2019-2023. Director Bert Crane requested one graph illustrating all wells and their levels.

PROJECTS: PROP 68 WATER PROJECTS UPDATE

Ms. Lindeman shared with the board that all boring field work by See's consulting had been completed on December 12th. Lab testing will take 3-4 months and then Summers Engineering will present the board with a report summary. We are anticipating a full soils report summary for the April/May board meeting.

GROUNDWATER SUSTAINABILITY AGENCY UPDATE

Mr. Samuelson explained to the board that at the March Merced Subbasin Groundwater Sustainability Agency (MSGSA) they will share a draft allocation policy with a Sustainable Yield (SY) and Addition Pumping Allowance (APA). The policy is scheduled to be approved at the April MSGSA meeting.
